




WHY BAHRAIN

100% foreign ownership

• Customs duty exemptions. Manufacturing, raw materials importing, plant machinery equipment, and spare parts are exempted from customs duty.

- High-standard industrial zones designed to meet the needs of tomorrow's businesses.




GATEWAY TO THE MIDDLE EAST



Road

Just a 30 minute drive to Saudi Arabia, the region's largest economy, through the King Fahad Causeway.



Sea

The fastest clearance time anywhere in the GCC when going through the Khalifa Bin Salman Port.



Air

The easiest and most direct access to all of the GCC's airport hubs, with I-hour flights from Bahrain International Airport.

0% tax

No corporate income tax or personal income tax.

35% cheaper

Cost of setting up and operating businesses is 20% – 35% cheaper than in other GCC countries.

Government grants

Investment grants are offered by the labour fund (Tamkeen).

Bahrain offers low industrial land lease rates with no additional fees or service charges.



Educated

89% of our ICT workforce holds either a Bachelor's or a Master's degree, and 44% hold another professional certification. (National Statistics)
