TAYLAND KRALLIĞI ANKARA BÜYÜKELÇİLİĞİ

Bilindiği üzere, Dünya Ticaret Örgütü Kuruluş Anlaşması Eki Gümrük Tarifeleri ve Ticaret Genel Anlaşması 1994'ün VI ncı Maddesinin Uygulanmasına İlişkin Anlaşma'nın (Anti-Damping Anlaşması) 6 ncı maddesinin 9 uncu fıkrası hükmüne göre, yetkili mercilerin nihai bir belirleme yapılmadan önce, kesin önlemlerin uygulanıp uygulanmayacağı kararının esasını oluşturan ve incelenmekte olan birinci derecede önemli gerçekleri ilgili tüm taraflara bildirmesi gerekmektedir.

Bakanlığımız tarafından, Tayland Krallığı menşeli 4007.00 gümrük tarife pozisyonu altında yer alan "vulkanize edilmiş kauçuktan iplik ve ipler" (lateks iplik) ithalatına yönelik olarak 5/9/2023 tarihli ve 32300 sayılı Resmî Gazete'de yayımlanan İthalatta Haksız Rekabetin Önlenmesine İlişkin Tebliğ (Tebliğ No:2023/23) ile başlatılan nihai gözden geçirme soruşturmasında nihai bildirim aşamasına gelinmiştir.

Bu çerçevede, soruşturma sonucunda alınacak karara esas teşkil edecek bilgi ve bulguların yer aldığı "nihai bildirim raporu"na "https://www.ticaret.gov.tr/ithalat" adresli internet sitesinden sırasıyla "Ticaret Politikası Savunma Araçları" → "Damping ve Sübvansiyon" → "Soruşturmalar", "NGGS-Tebliğ No:2023/23 – Vulkanize Edilmiş Kauçuktan İplik ve İpler (Lateks İplik) – Tayland Krallığı (Vulcanised Rubber Thread and Cord - Kingdom of Thailand)" → "Nihai Bildirim" başlıkları seçilerek ulaşılabilir.

Nihai bildirimde yer alan bulgulara ilişkin olası görüşler, **16 Temmuz 2024 Salı** günü mesai bitimine kadar Ticaret Bakanlığı'na ait "ticaretbakanligi@hs01.kep.tr" Kayıtlı Elektronik Posta (KEP) adresine veya posta yoluyla Bakanlığa iletilmeleri halinde dikkate alınacaktır.

Anılan soruşturma kapsamında **18 Temmuz 2024 Perşembe günü saat 14.30'da** kamu dinleme toplantısı düzenlenmesi planlanmaktadır. Toplantı çevrim içi olarak ve Türkçe dilinde yapılacak olup olası tercüme ihtiyacının katılımcılar tarafından karşılanması gerekmektedir. Söz konusu toplantıya iştirak edilecekse katılımcı sayısının iki kişiyi geçmemesi ve katılımcı ad soyad, unvan, firma/kurum, kamu dinleme toplantısına çevrim içi katılımda kullanılacak e-posta ve cep telefonu bilgilerinin **16 Temmuz 2024 Salı günü** mesai bitimine kadar "a.bozmert@ticaret.gov.tr" e-posta adresine bildirilmesi gerekmektedir. Toplantının gerçekleştirilmesine ilişkin detaylar katılımcılara bilahare e-posta yoluyla bildirilecektir.

Kamu dinleme toplantısında sözlü olarak verilecek bilgilerin, ancak yazılı olarak sunulmaları halinde dikkate alınmaları mümkündür. Ayrıca, gizlilik kaydıyla verilen bilgilerin gizli olmayan bir özetinin iletilmesi, verilen bilgilerin gizlilik içermemesi halinde ise bu hususun ayrıca belirtilmesi gerekmektedir.

As it is known, according to the provision of paragraph 9 of Article 6th of the Agreement on the Implementation of Article VI of the General Agreement on Tariffs and Trade, 1994, Annex to the Agreement Establishing the World Trade Organization (Anti-Dumping Agreement), before taking a final decision the competent authorities must inform all parties concerned of the primary facts under consideration, which form the basis for the decision whether to apply the measures.

The Ministry has reached to step of announcing the final notification report as a result of the investigation which was started for the import of “Vulcanised Rubber Thread and Cord” (latex thread) with 4007.00 GTIP number from the Kingdom of Thailand, upon publishing the notification of Prevention of Unfair Competition in Import (No. 2023/23) on the Official Gazette, numbered 32300, dated 5/9/2023.

In this context, information and findings that will form the basis for the decision to be taken as a result of the investigation are included in the "final notification report" and it can be received by following these steps: visit "<https://www.ticaret.gov.tr/ithalat>", "Ticaret Politikası Savunma Araçları" → “Damping ve Sübvansiyon” → “Soruşturmalar”, “NGGS – Tebliğ No: 2023/23 – Vulkanize Edilmiş Kauçuktan İplik ve İpler (Lateks İplik) – Tayland Krallığı (Vulcanised Rubber Thread and Cord – Kingdom of Thailand) → “Nihai Bildirim”.

Possible opinions regarding the findings in the final notification will be taken into consideration if they are submitted to the Ministry of Commerce’s email address of ticaretbakanligi@hs01.kep.tr until the end of the business hours of **Tuesday, July 16th, 2024**.

Within the scope of the said investigation, it is planned to hold a public hearing meeting on **Thursday, July 18th, 2024 at 14.30hrs**. The meeting will be held online and in Turkish, and any possible translation needs must be met by the participants. If the

meeting in question is to be attended, the number of participants must not exceed two people and the participant's name, surname, title, company/institution, e-mail and mobile phone information to be used for online participation in the public listening meeting must be sent to the email address of "a.bozmert@ticaret" until the end of business hours of **Tuesday, July 16th, 2024**. Details regarding the meeting will be sent to the participants via e-mail.

Information given orally at a public hearing can only be taken into account if they are also presented in writing. In addition, a non-confidential summary of the information provided under the condition of confidentiality must be submitted, and if the information provided is not confidential, this must be stated separately.
